SITE CONTRACT AND RENTAL CONDITIONS

Failure to comply with the under-mentioned clauses will result in
CANCELLATION OF SITE CONTRACT.

1. **Approved Goods:** When applications are made for sites the nature of goods wishing to be sold must be detailed and must not be changed after approval has been given. This applies particularly to foodstuffs and drinks as some lines are restricted to Showmen's Guild and others are approved lines to local Service Clubs and the Sarina Show Society Canteen.
2. **Allocation of Sites:** The organizers reserve the right to re-allocated space in the interest of a better showing of exhibits. Sites are available in multiples of 3 metres. Camping/staying on ground is at a cost of \$20 GST incl per night and is to be paid with Site Fees.
3. **Payment:** A deposit of \$50 must accompany Application for Site. Remaining fees are to be paid at the Office prior to taking up site.
4. **Cancellation:** No cancellation may be considered unless the Exhibitor applies for such release from his obligation in writing or email. No part of area may be sublet without approval of the President/Secretary of the Sarina Show Society.
5. **Damage:** The Society accepts no liability for damages to exhibits by loss, damage, theft, fire, water, storms, strikes, riots or any other cause whatsoever. All precautions are taken.
A security firm is engaged overnight during the Show to patrol the grounds.
6. **Liability Insurance:** The Society shall not be responsible for any damages claimed by any person or persons, who may be injured whilst in the Site allocated to the Exhibitor and the Exhibitor agrees to indemnify the Society in the event of any claim made against the Exhibitors. **Exhibitors are required to be able to produce a current Public Liability Insurance Policy with their application.**
7. **Electrical Appliances:** Site Exhibitors are to ensure **that ALL power leads and electrical appliances display a current tag** indicating that each lead has been tested and approved by an authorized person in accordance with requirements of the Workplace Health and Safety Act. i.e. that the lead has been tested after 1 January 2016/17.
8. **Fire Fighting Equipment & Electrical Switchboards:** No Site Exhibitor shall obstruct the use of any fire fighting equipment of electrical switchboards. Free access must be maintained to the above equipment at all times. Exhibitors are required to carry at least one fire extinguisher of approved type and be suitable for use on the display.

9. **Excavation:** Under no circumstances shall a Site Exhibitor excavate, dig or place pegs on the site without first obtaining the consent of the Site Officer of the Show Society.
10. **Exhibitor Passes:** Are available from the Secretary's Office prior to the Show.
11. **Advertising:** The display of approved advertising is restricted to the Site occupied by the Exhibitor.
12. **Offensive Material:** The President/Secretary shall have the power to enter the rented site described and remove any article, sign, picture or printed matter which in his/her opinion may be a cause of offence to the public or the Society.
13. **Fund Raising:** Only those specifically rented for the purpose of raising funds for Charity shall be permitted to sell Lucky Numbers, are Unions, Raffles and Lucky Dips tickets etc.
14. **Site Holders:** Must observe all provisions of the Food and Health Regulations.
15. **Cleanliness:** It remains the responsibility of the Site Exhibitor to ensure the cleanliness and tidiness of positions for the duration of the show.
16. **Behavior:** The Site Exhibitor or his representative are to conduct themselves in an orderly manner. **ALCOHOL MUST NO BE CONSUMED ON THE SITE.**
